**REQUEST FOR EXPRESSIONS OF INTEREST
FOR
ESTABLISHMENT OF A PANEL OF CONSULTANT FIRMS FOR COMMITTEE FOR ACCELERATION OF PRIORITY
INFRASTRUCTURE DELIVERY (KPIIP)**

In line with the developments of policies, the Government's strategy, and issuance of regulations concerning infrastructure, after observing problems arising in the field, KPIIP is encouraged by the issuance of the Presidential Regulation No. 122 of the Year 2016.

Part of the Scope of Amendment to Presidential Regulation No. 122 of the Year 2016 are: Additional regulations on the procedure for the performance of Panel of Consultants to shorten the procurement time. Through the Panel of Consultants, KPIIP will conduct pre-qualification and preliminary selection and award a 2-3 year umbrella contract to Consultants passing the selection. There will be 5 Panel of Consultant for KPIIP based on the requirement as follow:

- Panel 1 : 5 to 7 consortium or single consulting company with expertise in project preparation (Pre FS, FS and OBC)
- Panel 2 : 5 to 7 consortium or single consulting company with expertise in Legal for Infrastructure.
- Panel 3 : 5 to 7 consortium or single consulting company with expertise in Finance for Infrastructure.
- Panel 4 : 5 to 7 consortium or single consulting company with expertise in project implementation with expertise in Management and Technical Consulting.
- Panel 5 : 5 to 7 consortium or single consulting company with expertise in LARAP and Project Appraisal.

This Prequalification of Panel consultants shall be made in accordance with Presidential Regulation No 122 Year 2016 and Chairman of LKPP Regulation No 3 Year 2018 in the following two stages: the empanelment (Pre Qualification) stage and call-down (Assignment) stage.

The Procurement Committee for Panel Consultant KPIIP invites eligible qualified National and International Infrastructure Consultants to be contracted as member of KPIIP Panel Consultant. KPIIP will pre-qualify consultants that are capable of providing Infrastructure Consulting Services and these consultants will be contracted as Panel Consultant KPIIP for two fiscal year with a framework contract (IDC).

Call down assignment stage: After selected as the member of the Panel Consultant KPIIP, consultants shall be engaged by specific Work Unit (Satker) which responsible for specific PSN or PIP. Each work unit shall lay down the principles for defining the firms from the panel to which the request for proposal documents (RFPs) shall be issued at the call-down stage. The RFPs at the call-down stage shall be issued preferably to ALL the consortias or firms in the related Panel.

Interested Consultant shall submit its Expression of Interest (EOI) and its qualification with the form provided by Procurement KPIIP in the Request for Expression of Interest (RFEOI) Document.
